City's Top Storyteller, Susan Gray, Retires from Historic Resources

Susan Inskeep Gray was drawn to Fairfax City in 1998 by the opportunity to help tell its rich, complex story. She learned the city's history as she helped bring it to life through exhibits, events, community presentations, and activities. She retired June 1 after a 25-year career with the Office of Historic Resources.

"When I arrived, our first exhibit covered our history from Native Americans through the Civil War. But that's only one segment of Fairfax history," said the former historic resources director. "Lord Fairfax is important. What happened here during the Civil War is important. But there is so much more."

During her tenure, Historic Resources has explored what makes Fairfax City unique. She was particularly drawn to the post-

Civil War and post-World War II eras, where, she said, "the city was a setting for all of those issues and national events."

Historic Resources brought local historic figures to life, presenting the public and personal stories of Richard Farr, Antonia Ford, Kate Waller Barrett, and Kitty Pozer. But, she said, everyone makes history every day.

"You are a part of this story," she told visitors, especially youngsters. "If you've been here a week, if your family is from Bangladesh, you're part of the Fairfax story now, and you're just as important as someone who came in 1780."

The main exhibition at the museum is called "The Fairfax Story" because, she said, "History is the story of us."

She commended Historic Fairfax City, Inc., for supporting the establishment of the historic resources office and for continued support. "HFCI understood the importance of historic facilities and their management," she said, citing their guidance on research and restoration of numerous city historic buildings.

She is grateful for relationships with the City of Fairfax Regional Library, the Virginia Room, the Library of Virginia, and George Mason University, where she earned her graduate degree in 1996.

She praised her staff and the city departments and was thankful for myriad volunteers.

All of these partnerships have allowed historic resources to celebrate the city's diverse culture, from the spacesuit worn by a Fairfax City native to the costumes of Bolivian dancers in the city's annual Independence Day parade. She said, "There are so many stories yet to tell."

COUNCIL ACTIONS OF SEPT. 9, 2025

PRESENTATIONS AND PROCLAMATIONS

- Mayor Catherine Read presented proclamations acknowledging Sept. 17-23 as Constitution Week, and Sept. 22 as Car Free Day in the City of Fairfax.

ADOPTION OF THE AGENDA

- Approved, unanimously, the adoption of the agenda.

CONSENT AGENDA

- Approved, unanimously, consideration of the minutes of special meetings for July 22, Aug. 12, and 26, 2025; and minutes of regular meeting for July 22, 2025.
- Approved, unanimously, the appointment of city residents James Hickman and Nicholas Prosinin to the Fairfax City Parks Foundation Board, and Susan Wiczalkowski to the Retirement Plan Administrative Committee.
- Approved, unanimously, award of professional service contracts for architectural design, engineering, and construction management services to Architecture, Inc. and Moseley, Inc. for renovations and additions to Providence and Daniels Run Elementary Schools. Combined expenses for both projects in FY 2026 will not exceed \$3M. Future funding is contingent upon city council approval of appropriated funding.
- Approved, unanimously, award of construction contract in the estimated amount of \$1,727,333.60 to Virginia Paving Company for reconstruction and rehabilitation of the east and westbound roadway of Fairfax Boulevard between Draper Drive and Fairfax Circle.
- Approved, unanimously, to adopt an updated resolution to endorse applications for FY 2029-30 Revenue Sharing Funding for 1st/2nd Street Sidewalks, Dwight Avenue Pedestrian Improvements, and Northfax East-West Roadway.

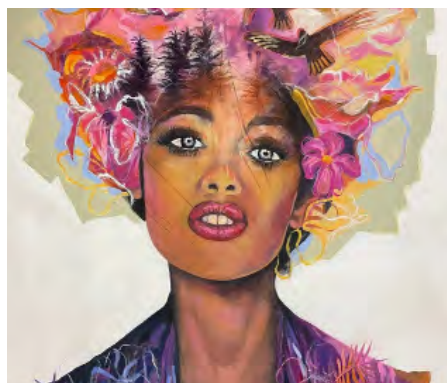

If you pay real estate taxes directly and do not receive a tax bill, call 703-385-7900. If you receive a real estate tax bill but your mortgage company escrows the payment, please immediately forward the bill to your mortgage company.

Interest-Free Loans Available for Tax Payments

City residents may apply for interest-free loans to pay real estate taxes and personal property taxes through the Taxpayer Assistance Program. Borrow \$250 - \$15,000 and repay monthly for six to 10 months. Apply in person with the Treasurer's Office in Fairfax City Hall. There is a 7.5% application fee payable to the partner bank, Main Street Bank. Info: fairfaxva.gov/tap, 703-385-7900

Tax Relief Available

Fairfax City provides real estate tax relief options to qualified senior citizens and homeowners with disabilities. Additionally, disabled veterans (or their surviving spouses) may be eligible for real estate tax exemptions on their principal residences. Applications are due April 15, 2026. City Thanks Edwin Gonzalez for His Service

After 34 years, Edwin Gonzalez, refuse and recycling supervisor, retired from the City of Fairfax Nov. 1. He spent his entire career with the Public Works Department, starting in 1991 as a temporary leaf collector, then as a temporary refuse worker the following year, before being hired as a permanent employee in 1993.

After earning his commercial driver's license, he took every opportunity to learn new skills and advance his career: truck driver, equipment operator, assistant supervisor, and ultimately supervisor of the city's refuse and recycling division. "I was the first Hispanic person to work at the Property Yard in 1991," he said. "I've seen a lot of changes since then."

He has seen how recycling has changed the landscape, literally, as fewer materials are sent to the landfills. He has seen technology improve service and working conditions, from

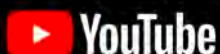
cameras that help staff avoid accidents to hydraulic lifts that prevent worker injuries. He saw his department continue operations during all weather conditions, season after

season, and even through a global pandemic. He has seen the city grow and change in 34 years, and he still knows every street, every block, every address on every route.

He understood the assignment he was given decades ago: provide excellent service, no matter the conditions. "I like to serve the residents of Fairfax," he said. "I'll do anything to help them — and I've tried to pass that on to my coworkers: to do their best for the residents. They deserve the very best service."

And he remembers his customers. A young boy on his route decades ago was so impressed with the brush collection truck, he pointed at Gonzalez and said, "I want to be him when I grow up." Years later, he saw the young man, now a college student, who still remembered that day.

"[Former Public Works Director] Glen Shelton told me, 'This is a good place to stay.' And he was right," said Gonzalez.

The Real Estate Assessments Office has five staff members who are responsible for valuing all residential and commercial property in the city — about 9,685 properties in total.

I am a residential appraiser, and I have been with the city for eight years. What goes into an assessment is a lot more complex than most people realize. I didn't fully understand the complexity until I joined the assessment team. We do everything possible to make sure our assessments are accurate and equitable.

We are here to help residents if they have questions about their assessment. There is an appeal process first at the administrative level, which allows us to look more closely at their parcel. The second level of appeal is to the Board of Equalization, which is a panel of volunteer city property owners with financial, real estate professional, or construction backgrounds.

I am currently studying for my assessment administration specialist master exam, which recognizes professionalism and competency in the administration of a variety of functions for property tax purposes. Continuing education is important in our industry.

The city is full of wonderful people; it's a privilege to be a part of the City of Fairfax.
