TO THE APPLICANT:

To assist you in completing your notice of appeal an application is attached for your use. Please follow the instructions carefully, as no appeal will be processed until all required materials are submitted to the Zoning Office (Room 207A, City Hall). A notice of appeal must be submitted in writing within 30 days of the final architectural review decision (Certificate of Appropriateness) which is the subject of the appeal.

Zoning Ordinance §6.5.3 provides that the Director has authority to approve all minor Certificates of Appropriateness and the Board of Architectural Review has authority to approve all major Certificates of Appropriateness. In conjunction with other actions the City Council may approve major Certificates of Appropriateness. Zoning Ordinance §6.5.13 provides that final decisions on Certificates of Appropriateness may be appealed to the City Council within 30 days of the decision in accordance with §6.22. Where the City Council made the final decision on a major Certificate of Appropriateness a notice of appeal is made to the Circuit Court. The City Council appeal process is not applicable for appealing decisions of the Zoning Administrator or the Board of Zoning Appeals or the City Council in approving a Certificate of Appropriateness.

The written notice of appeal must be submitted in accordance with Zoning Ordinance §6.2.3 and must show that the applicant has an immediate, pecuniary and substantial interest in the litigation, and not a remote or indirect interest. Once a fully completed notice application, fee and all mandatory information as may be required by the Zoning Administrator is received by the City Clerk and deemed complete, the notice of appeal will be distributed to the City Council and the Zoning Administrator. Notice of the public hearing will be given by the City Clerk in accordance with §6.2.5 of the Zoning Ordinance. The written decision will be forwarded to the applicant by first class mail within five (5) days after final decision.

Final decisions of the City Council may be appealed to Circuit Court within 30 days of the decision in accordance with §6.23.
