You will need the following information on hand before you enter the portal:

- Account Number
 - Located on your bill in the upper right-hand corner
 - If you cannot find the number, please contact the Treasurer's Office 703-385-7900 or email treasurer@fairfaxva.gov for the account number
- Last 4 numbers of Social Security Number (SSN), Federal Employer Identification Number (FEIN) or Driver's License Number (DL)

Taxpayers will be asked to create an account to make a payment through City of Fairfax online tax portal.

Creating an account will provide the following new features:

- Register for eAlerts and receive tax bills electronically
- Ability to schedule payments
- Easily monitor and pay invoices
- Notification and quick view of changes/updates to invoices
- Create a watchlist for multiple accounts

Step 2 - Creating a login

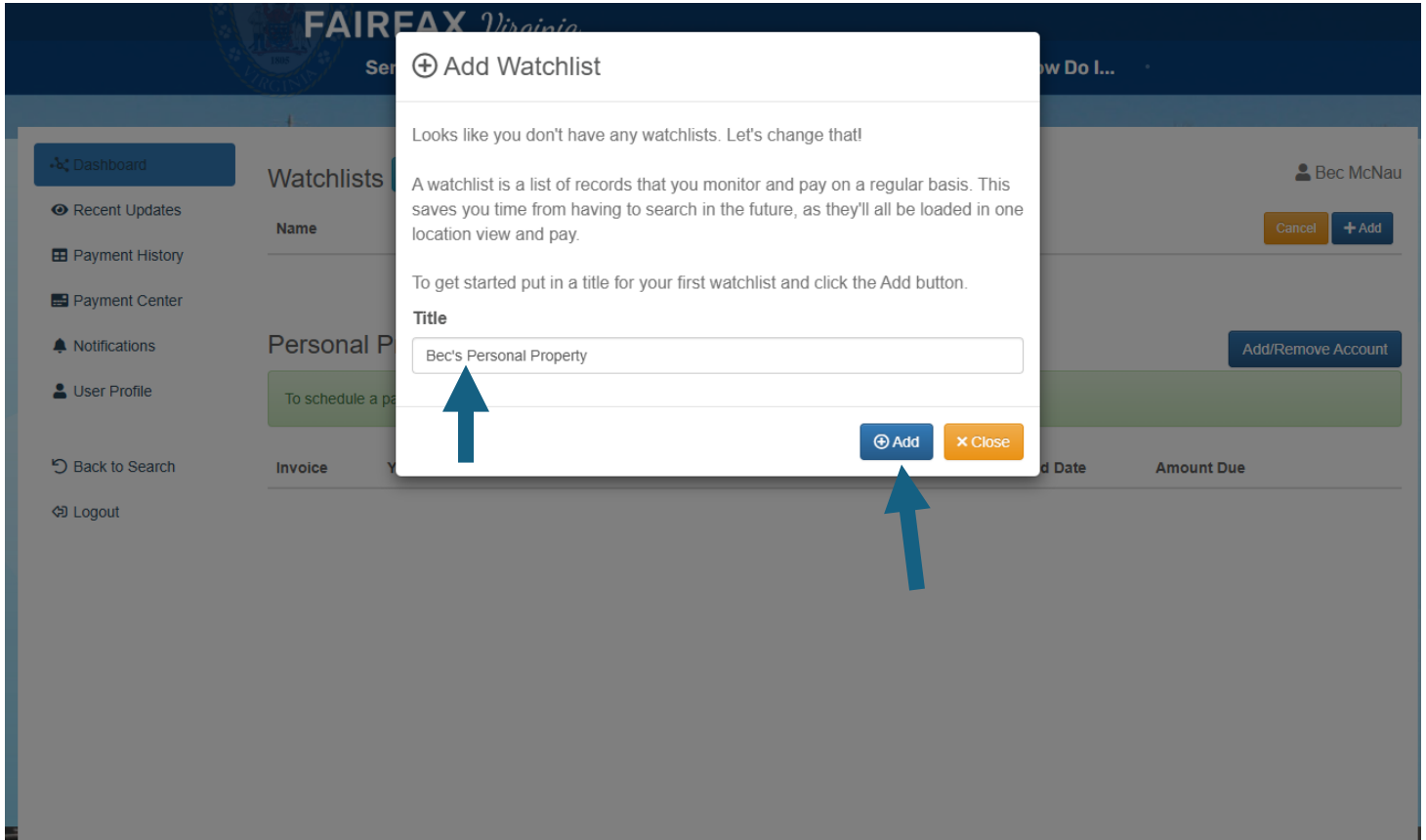
- All fields must be completed to create a login
- Password must contain at least:
 - 8 characters
 - 1 upper case
 - 1 number
 - 1 special character

Click **Signup** once completed

Step 3 – Add Watchlist (REQUIRED)

You are required to create/add at least one “Watchlist”. A watchlist is a list of account numbers or a single account number.

- Fill in the title (any name will do) and click: **ADD**

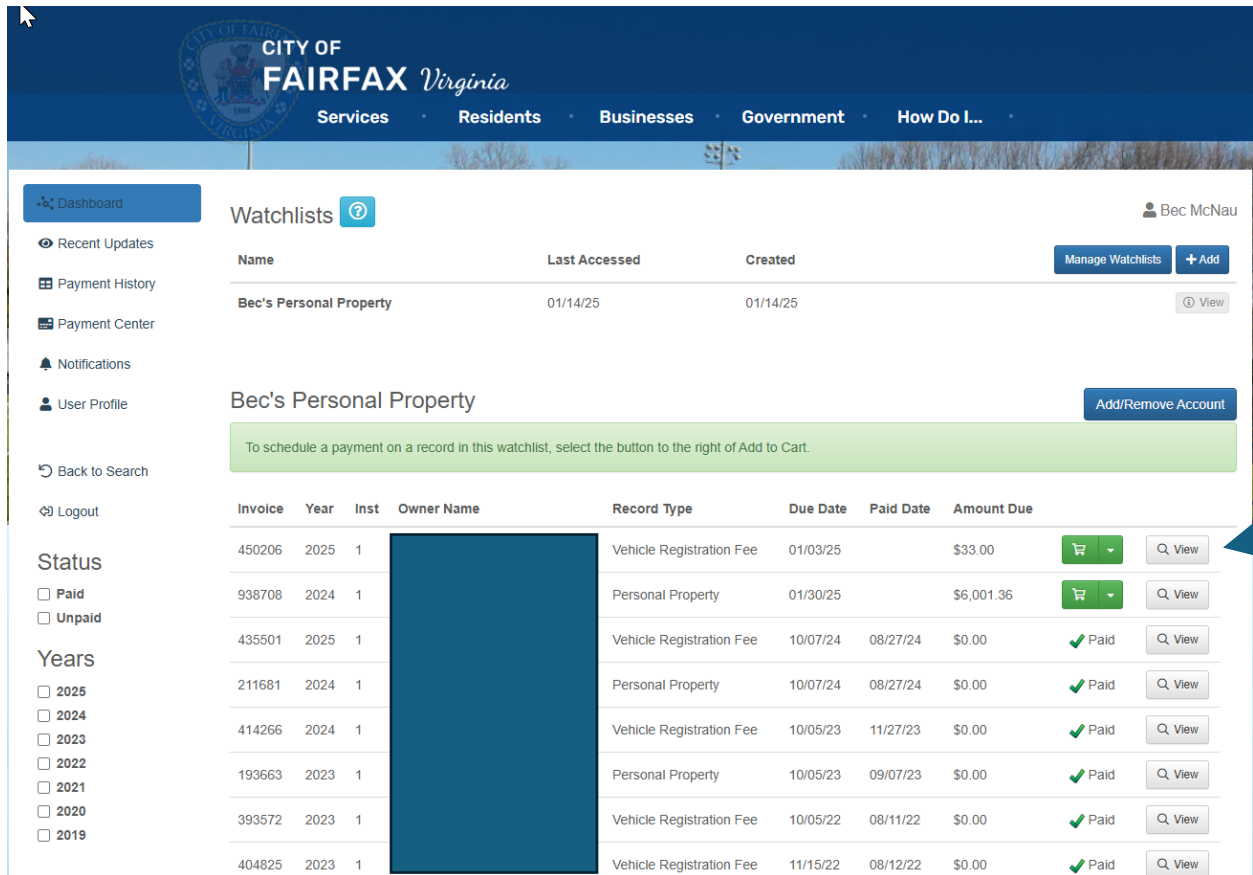
